General Rules are as follows:

- (1) A contestant must be at least 13 year of age prior to January 1, 2010 and must not have reached their 18<sup>th</sup> birthday prior to January 1, 2010 and must not be enrolled beyond their junior year in high school.
- (2) Must be enrolled in public or private school.
- (3) Must be willing (1<sup>st</sup> place only) and able to use certificate of purchase for the purchase of an animal to be shown in the SandHills Stock Show in 2011.
- (4) Must meet academic requirements to participate.
- (5) A contestant CANNOT scramble under both 4-H and FFA.
- (6) We also suggest each participant's maximum weight should not be less than 100 pounds and they should be in top physical condition.
