The undersigned exhibitor agrees to control all animals exhibited by him so as to prevent injury to persons and property and the undersigned exhibitor shall indemnify and hold the Sandhills Hereford and Quarter Horse, Inc. and its officers, directors, managers and employees, harmless from all damage an injury caused to any person or property by his animals and from any claims or legal proceedings incident to such claims.

We the junior exhibitor and parent/guardian, certify that we have read and understand and will abide by all the rules and regulations of the Sandhills Stock Show & Rodeo, including but not limited to the **RESIDUE AVOIDANCE PROGRAM** as set forth in the Premium Handbook. We further certify that we have not administered to this steer, lamb, wether goat (circle all that apply) entry, nor has it received any substance not approved by the Food and Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) for slaughter animals. Further, any drug which requires the prescription of a veterinarian must be disclosed to the officials of the Stock Show, in writing, together with the attached prescription. At the sole discretion of the superintendent of the class in which the animal is entered, the animals may be disqualified if the prescription drug is believed to be performance enhancing. Failure to disclose the fact that an animal has been administered a prescription drug will result in disqualification.

The undersigned certifies that, to the best of his/her knowledge, none of the cattle or other ruminants have been fed any feed containing protein derived from mammalian tissues, e.g. ruminant derived meat and bone meal, not in compliance with 21 CFR 589.2000.
